1. Sales may begin at 10 a.m., Friday, July 25, 2008 and continue until 6 p.m., Sunday, July 27, 2008. You may close at any time at your own discretion.
2. Organizations/individuals shall be responsible for their own booth and the safety thereof. Neither the Lovelock Frontier Days Committee nor the Greater Pershing Partnership assumes any responsibility for theft or damage to items in vendors' booth. Any such occurrences should be reported to the local authorities.
3. The Frontier Days Committee does not carry insurance coverage for individual vendors. The committee strongly recommends insurance coverage be secured for each vendor. If you do not have insurance or choose not to purchase any, please sign below releasing Lovelock Frontier Days and the Greater Pershing Partnership of all liability.
