If you require electricity less than 12 Amps, you must be located in the designated electrical spaces against the courthouse and you may NOT run extension cords across the walks or lawns. If you need other arrangements please let us know prior to your arrival and we will make every effort to accommodate your needs. If you need more than 12 Amps of electricity, you must provide your own generator. The generator spaces are located on the perimeter of the park and are labeled 1G-6G.

Vendor's spaces will be assigned on a first come, first served basis. Vendors must check in at Headquarters prior to setting up. 2. Organizations/individuals shall be responsible for their own booth and the safety thereof. The Lovelock Frontier Days assumes no responsibility for theft or damage to items in vendors' booths. Any such occurrences should be reported to the local authorities.
3. **The Frontier Days Committee does not carry insurance coverage for individual vendors. Please provide Proof of Insurance. Please sign below, releasing Lovelock Frontier Days of all liability and agreeing to this stipulation.**

1. VENDORS: Any product deemed a nuisance or a hazard by the committee will be removed.
2. The committee prohibits the sale of stink bombs, disappearing ink, offensive odor spray, spray hair paint, any explosives or explosive devices, projectiles of any type, all air soft toys, and any toy gun other than water guns.
3. All knives, swords, etc. must be in a locked case out of reach of customers. Children under the age of 18 years are not allowed to handle or purchase knives or swords.
4. Alcoholic beverages may be sold only by the Frontier Days Committee.
5. The Lovelock Frontier Days Committee reserves the right to close down any booths if the items sold vary from the lists provided by the vendors and/or the vendors are not following the guidelines provided in the vendor packets.
